# THE BUSINESS OUTLOOK AND THE IMPACTS OF THE AFRICAN CONTINENTAL FREE TRADE AREA: CHALLENGES AND OPPORTUNITIES

#### **Session brief**

Today more than ever, Africa offers unique **business opportunities** thanks to the recent implementation of the **African Continental Free Trade Area** (AfCFTA), the largest in the world, connecting almost 1.3 billion people across 54 countries with a combined GDP of roughly 3.4 trillion US dollars. With the mandate to eliminate tariffs and barriers on intra-Africa trade over 5 years, it could become a turning point to unlock Africa's growth potential by bringing more than 1 trillion US dollars GDP increase by 2025; increasing the African workforce to 325 million by 2030; fostering intra-continental trade by 52% before 2022 and promoting inclusion thanks to ad-hoc protocols focused on women and youth.

Thanks to greater economic integration and interconnection, European and African companies will benefit from win-win business partnerships. Inspired by the European internal market for goods, services and people, what are the best practices that can be shared with the AfCFTA? How will the area promote growth and inclusivity across the continent?

# 12:15 – 13:15 BUILDING PHARMACEUTICAL HUBS ACROSS AFRICA: THE IMPORTANCE OF CROSS-BORDER PARTNERSHIPS

#### **Session brief**

There is only one way out of the Covid-19 crisis: universal vaccination coverage — no one is safe until everyone is safe. The development of a **resilient**, **efficient pharmaceutical sector** is thus a matter of national security and an essential requisite, above and beyond regional competitiveness. According to the African Centers for Disease Control and Prevention, 99% of the vaccines are imported. At the same time, the pharmaceutical industry reports one of the highest rates of growth.

In this context, and based on the vaccine experience, Africa has the opportunity to strengthen and develop pharmaceutical hubs across the continent, specifically in **South Africa**, **Ghana and Ethiopia** thanks to a favorable business climate and strong infrastructures. Extra-African financial flows would be replaced with **know-how and technology transfers**, to produce pharmaceutical products and vaccines locally. It is a complex challenge, but just because of Covid-19, there has never been a more favorable moment to work toward a stronger and more self-sufficient pharmaceutical industry that goes beyond vaccines.

In this regard, the session will also highlight the **role of the Italian Trade Agency** (ITA-ICE) as a key stakeholder in the promotion and facilitation of international partnerships between Italy and target countries like, ideed, South Africa, Ghana and Kenya.

#### **Session brief**

In light of the pressing needs represented by **climate change** worldwide, 2021 represents a key year with global gatherings to address and reflect on concrete actions to be implemented at national and international levels. Although the African continent only contributes with 5% of the world's total greenhouse gas emissions, it is extremely vulnerable to the consequences of climate change that might hinder the social and economic development of the region. Three megatrends can be identified and discussed: decarbonization, digitalization and decentralization.

The current **energy mix** in Africa is extremely heterogenous, relying on different sources such as coal, oil, natural gas, hydropower and bioenergy. This diversity will help Africa to increase its resilience to climate change induced volatility, by fostering regional interconnection, technological development and efficient infrastructures. This is a critical challenge especially for South Africa, where energy efficiency problems need to be urgently addressed.
