

The Solution A new form of transportation



Speed

Break the limit of continental distance

Distances greater than ~600km are more efficiently travelled by air

Urban landscape redefined

Suburbs will become part of Cities

Cities will be connected to become Megacities Cities 50km area

Maximum ~600km

between city pairs

Hyperloop

3,000km

Megacities 500km area



Transcontinental Network for Passengers and Hyperloop Prime Now service

Big cities can be fed with final orders from one single location, providing inventory and labour costs reduction all through the chain, and allowing **Prime Now services** on a continental basis.






Hyperloop Transportation Technologies: Building Breakthrough Innovations in Crowd-Powered Ecosystems


